ABOUT THIS PRODUCT

As defined, Graffiti-B-Gone! is vitality marked by an abundance of vigor and enthusiasm when tackling your tagger's latest handiwork. Safe for most surfaces. Removes a variety of products including but not limited to spray paint, permanent markers, lip stick, fingernail polish, ink, pencil marks, shoe polish and many others.

DIRECTIONS

To use, test in a small area to be certain that Graffiti-B-Gone! will not harm the surface to be cleaned. While our product is safe to use for most people, as with any chemical product it is always recommended to take precautionary measures and wear protective clothing.

Recommended Applications: For most smooth surfaces such as chalk boards, glass, doors, siding, fiberglass, aluminum siding, utility boxes, most street signs and smooth granite or marble type surfaces, simply spray on Graffiti-B-Gone! and wipe off with a clean towel or cloth. For surfaces such as plexiglass or some painted surfaces, spray on and wipe off, do not allow Graffiti-B-Gone! to remain on surface long or a 'hazing' will appear. For concrete, brick, stucco and other porous masonry-like surfaces, it is recommended to spray on and let sit for 10-15 minutes allowing product to soak down into the pores, then use a high pressure power wash system to spray the graffiti off.

PRECAUTIONARY STATEMENTS

Prevention: Keep away from heat/sparks/open flames / hot surfaces. No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion-proof electrical/ ventilating / lighting/ equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Wear protective gloves/ eye protection/ face protection. Wash hands and face thoroughly after handling. **Response:** IF ON SKIN: Wash with plenty of soap and water. For specific treatment: see section 4 on the Safety Data Sheet. If skin irritation occurs: Get medical advice/attention. Take off contaminated clothing and wash it before reuse. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/ attention. IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. In case of fire: Use dry sand, dry chemical or alcohol-resistant foam for extinction. **Storage:** Store in a well-ventilated place. Keep cool. **Disposal:** Dispose of contents/container in accordance with local/regional/ national/ international regulations.
